- JTM Cargo Management has no obligation to provide, or continue to provide, credit facilities. If at any time you exceed your credit limit or credit terms, consignments will require payment in full prior to delivery. You agree to immediately pay storage or additional charges resulting from late payments.
- Overdue payments may incur a minimum monthly financial accommodation and administration charge of AUD \$50.00 per month.
- The Customer must pay the Supplier all bank fees, charges, Debt Recovery collection fees and legal

- costs payable by the Supplier because of the non-payment of money due to the Supplier, or for non-clearance of a payment by the Customer to the Supplier.
- The Supplier reserves the right to amend the Terms and Conditions of Credit and the Standard Trading Terms and Conditions from time to time with or without notice.
- The Supplier reserves the right to withdraw without notice.
